#### Current Business Background about the operational structure and the Business Strategy:

We had visited Registered office of the Company situated at Anubhav Plast Limited, 7/41 A, Basement, Basant Tower, Tilak Nagar, Swarup Nagar, Swarup Nagar, Swarup Nagar, Uttar Pradesh, India, 208002.

Gupta & Co., Chartered Accountants, about the aspects of Finance and aspects relating to the Restated Financial Statements of the Company for the financial years ended March 31, 2025, 2024, 2023.
- 2. We have had elaborate discussions with the Legal Advisor to the Issue with respect to the legal matters and statutory aspects pertaining to the Company, Promoter, Promoter Group, Directors and the Group Company.



- 3. We examined the MOA and AOA of the Company, relevant Board and Shareholder Resolutions of the Company and confirmed that the Company is eligible to offer their shares to public through the IPO.
- 4. 


#### 7. Conclusion:
