The Company intends to undertake the Issue and list its Equity Shares at an opportune time in consultation with the book running lead managers appointed for the Issue (the "**BRLMs**") and other advisors to be appointed for the Issue and subject to applicable regulatory and other approvals, to the extent necessary and in this regard, following resolution was passed unanimously:
