

I. Project Overview and our Scope of Work:

The Company is intending to set up Crash Barrier and Solar Panel Structure manufacturing plants at its existing facility on Gata No.1354, Kisarwal, Tehsil – Akbarpur, Kanpur Dehat ("proposed project") where, the company is already engaged in manufacturing Steel Tubes and Steel Tubular Poles.
