The Company is in the process of establishing a setting up a new manufacturing facility for the production of crash barriers and solar panel structures within its existing manufacturing premises located at Gata No. 1354, Kisharwal, Rania, Akbarpur, Kanpur, Dehat (Unit II) Khata No. 157 and 166, Gata No. 1354, Village Kisharwal, Akbarpur, Kanpur Dehat, Uttar Pradesh.

As per Pursuant to Circular No. G 29267/C-4/सा. 62/2019 dated January 09, 2019, issued by the Uttar Pradesh Pollution Control Board, a total of 156 industrial sectors have been categorized identified under the "White Category." of the industries. As per Serial No. 2 of Table II – White Category, the activity relating to fabrication /manufacture of crash barriers and solar panel supporting structures falls within the White Category. The production of crash barriers and solar panel structures falls under Serial No. 2 of Table II - White Category, and hence, such activities are exempt from the requirement of obtaining Consent to Establish (CTE) from the Pollution Control Board.

In terms of the said Circular, industrial units falling under the White Category are exempt from obtaining Consent to Establish (CTE) from the Uttar Pradesh Pollution Control Board. Accordingly, the Company is not required to obtain CTE for the aforesaid proposed manufacturing activities.
